# Teachers and staff have access to PPE every day.



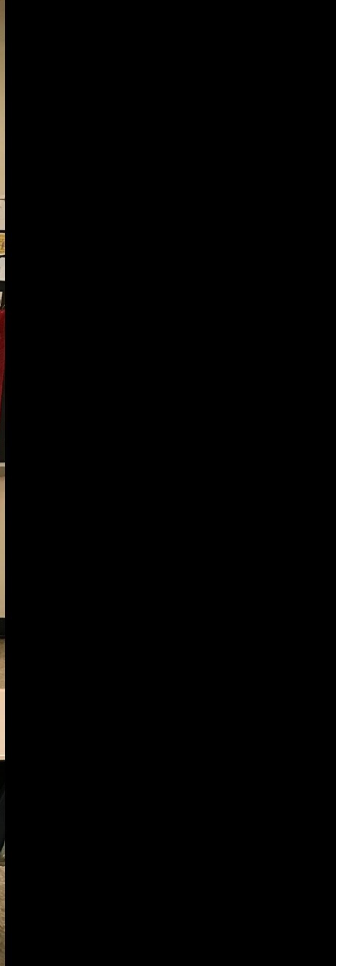


# Classroom Ventilation

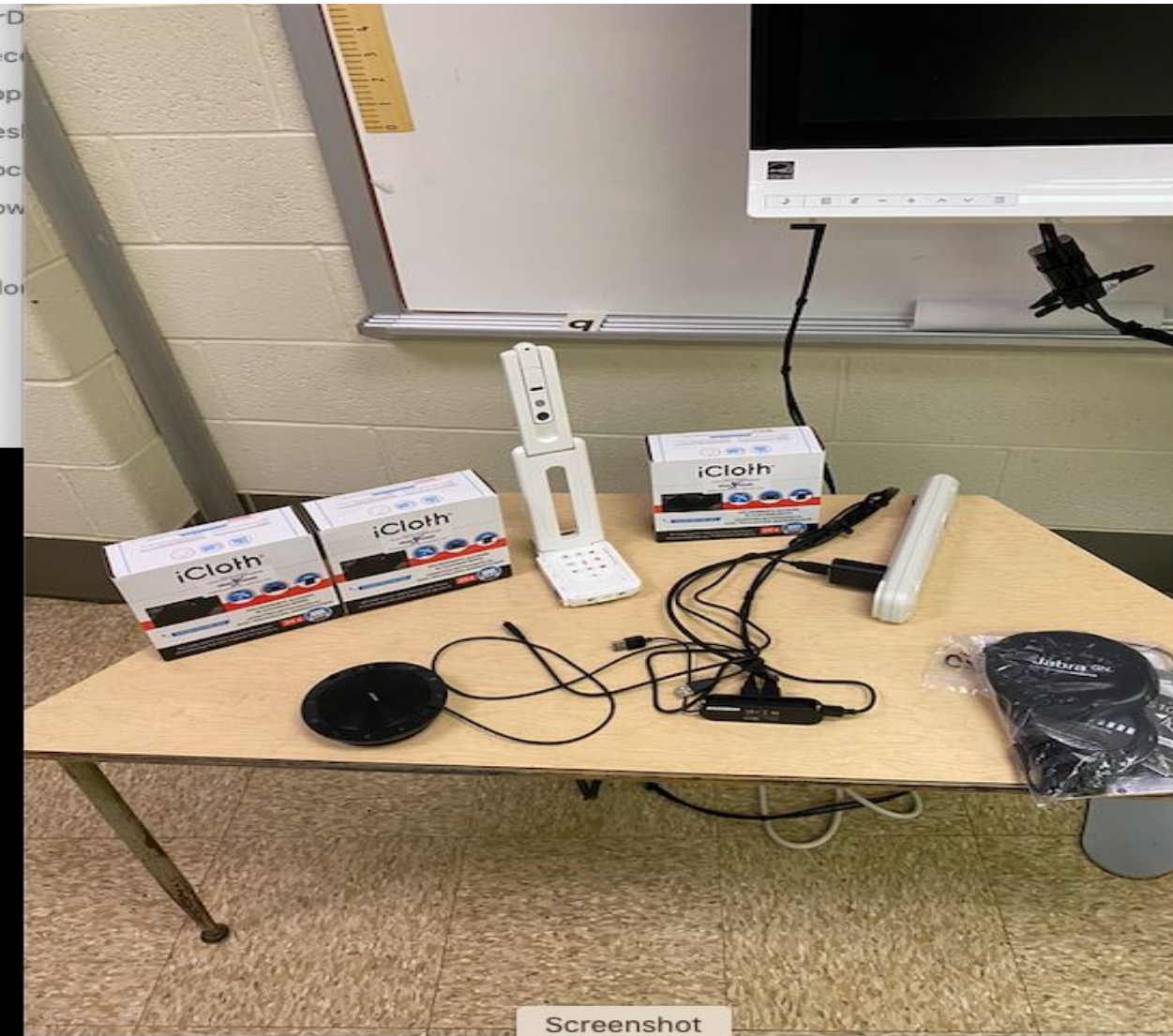


# Our classrooms are cleaned and organized for safe in-person/hybrid learning.

# Where does my child enter?

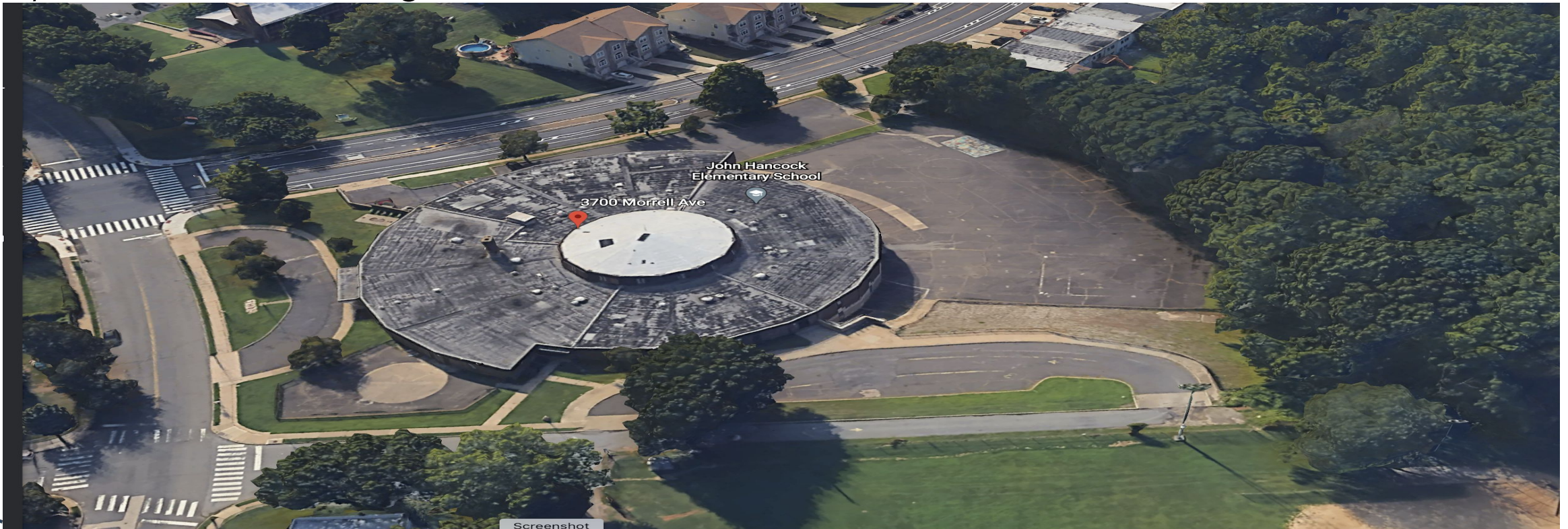
- Ms. Hartman -Room 200, Ms. Watson 213 and Ms Ketterer 215 will arrive at the front entrance and be dropped off in the front car loop. Please park on the street and shut off your car.





# Where does my child enter?

- Ms. Dougherty-Rooms 217 and Mrs Link/Ms. Orth - 219: Parents will need to walk their children into the kindergarten yard. Please park on the street and shut off your car. Kindergarten students will need their family member to safely escort their child through the kindergarten yard and to the kindergarten door entrance.





# Where does my child enter?

- 1st Grade -(Ms. Bonner, Ms. Vaughan, Ms. Beltz ) 209 ,210, and 211 will be dropped off in the car loop and will enter through the Red door. Parents will need to continue moving through the car loop once their child is dropped off.





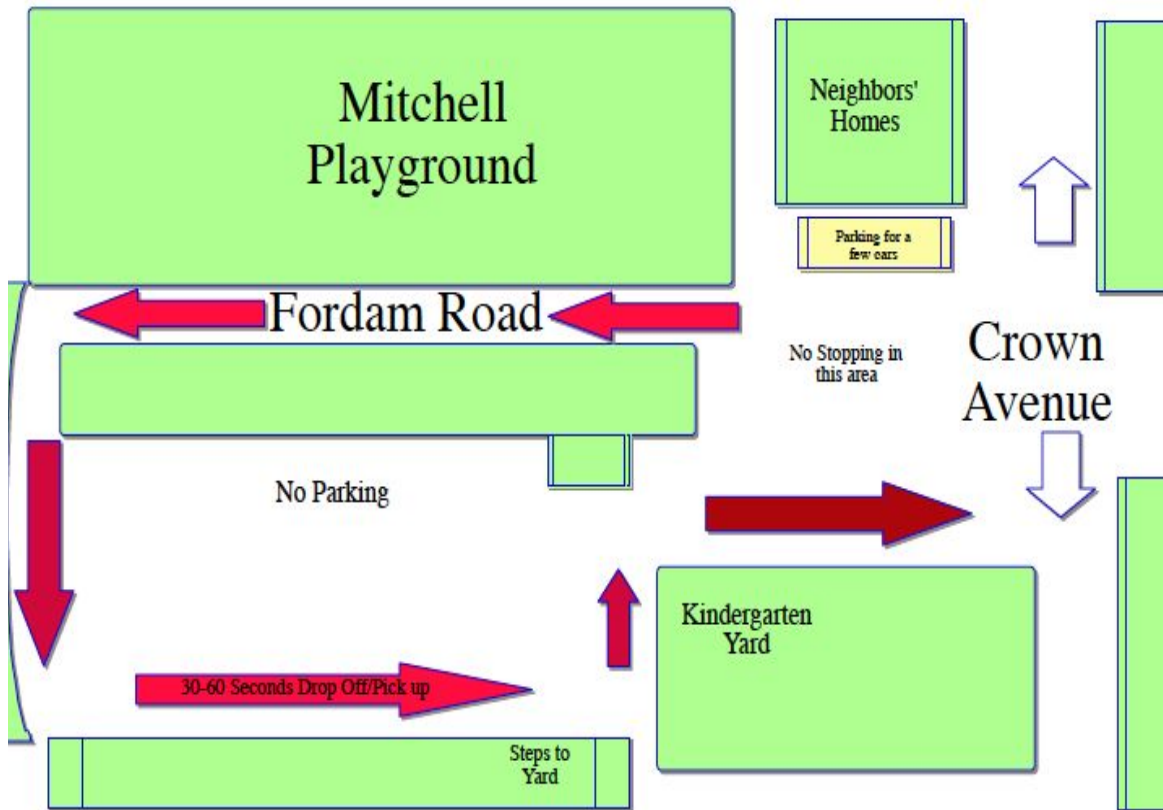
# Where does my child enter?

- 2nd Grade - (Ms. Montgomery, Mrs. Fogarty and Mrs. Glavin) Rooms 206, 207, and 208 will be dropped off in the car loop and will enter through the Yellow door. Parents will need to continue moving through the car loop once their child is dropped off.

# Where does my child exit?

- Parents and guardians who pick up students at the front door will need to park on the street or in the larger side car loop and walk up to the loop to pick up their child.
- Room 213 and 215 students will remain in the library (socially distanced). Parents and guardians of students in these classrooms ring the bell and their child will be brought to them.





# Where does my child exit?

- **The Kindergarten students will be dismissed at 3:05 PM.**
- Room 200 will exit through the kindergarten hallway and line up to the alongside the kindergarten gate on the sidewalk (facing the school)
- Students in room 217 and 219 will be dismissed through the kindergarten door and will line up (socially distanced in the kindergarten yard) to be picked up by their parents or guardian.
- Kindergarten teachers must not come out before 3:05 PM.





# Where does my child exit?

- **First and Second grade students will be dismissed at 3:09 PM.**
- First grade will go out through the announcement doors (Stairwell #2) and line up (socially distanced) to be dismissed from the school yard.
- Second grade will go out through the rainforest doors and line up (socially distanced) to be dismissed from the school yard.
- We will continue to use the car loop for pick up. The loop will be used as it has in previous years. Car engines must be shut off. The car loop will function as it typically does. Once a car parks in the loop, they will need to remain there until the loop is reopened. The loop will be closed to cars entering the loop at 3:05 PM.
- First and second grade teachers must not come out before 3:09 PM.

# Routine COVID Testing

- Any student who will be participating in hybrid learning must have parent consent completed for the routine COVID-19 testing.
- Students who do not submit parent consent for testing WILL NOT be permitted to participate in hybrid learning.



# Breakfast, Lunch, & Recess

- Students will eat breakfast and lunch in their classrooms.
- All students will have recess.
- Recess will be held outside - weather permitting.
- Students will be separated by classroom.
- Social distancing will be followed.



# Uniforms

## **Students may wear either their regular uniform or their Gym uniform.**

- Regular uniform: Navy blue or white shirts with collars and navy blue or khaki slacks. Shirts must have collars. Girls may wear khaki slacks, knee length navy blue skirts, knee length navy blue skorts or jumpers if desired. Shorts are only permitted during the following months: September, October, April, May, and June. When shorts are appropriate, to the knees is the required length. No jeans, sleeveless tops or midriff tops are permitted. Leggings are not permitted as part of the Hancock uniform. Girls may wear navy or white stockings or leggings under their skirt if the weather is cold. When cold in the classroom, students may wear navy blue, white or khaki sweaters or crew neck sweatshirts over their uniform shirts. Hooded sweatshirts are not permitted.
- Gym uniform: Navy and/or gold t-shirts and navy sweatpants in cold weather, and navy and/or gold t-shirts and navy shorts or sweatpants in warm weather. Sneakers are required. \*Gym uniforms are permitted on all days during in-person Hybrid Learning.
- Logos are not permitted on clothing with the exception of Hancock or LaBrum School Logo clothing.
- Footwear may be shoes or sneakers. Light up sneakers and skate sneakers are not permitted. Shoes must have rubber soles. Sneakers are recommended footwear. No open toe shoes, or heels are permitted.
- All students should come to school clean and well-groomed. Good personal hygiene is practiced at home as well as in school.
- Please note that given the limits of special area class opportunities because of the hybrid model, students will have gym more frequently than usual.
