John Hancock Demonstration Schoolwill take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

A Back to School Night will be scheduled in September 2021. During this event, a special Title I parent meeting will be held. Per parent suggestion, Administration will consider hosting the opening portion/Title I meeting virtually and streaming it into the individual classrooms - this will prevent the cafeteria from becoming crowded as well as allow for this portion of the event to be recorded for parents who are unable to attend Back to School Night.

During Back to School Night in September 2021, we will address the State Academic Standards with our parents. In addition, Hancock Schools holds workshops for parents throughout the year to ensure that parents understand the curriculum, state standards, and academic assessments and how parents can work with educators and monitor student progress. Individual student progress is also discussed at Report Card Conferences and provided by quarterly Interim reports. Parents also have access to student progress through the School District of Philadelphia's Parent Portal. Additionally, we hold parent workshops on strategies for parents to support their children and have Family Educational Events. During our monthly School Advisory Council (SAC) meetings, there will be intentional opportunities provided to encourage parent input. In order to encourage greater participation at SAC, flyers will be utilized to advertise the meetings and include key topics to be discussed. School Leadership teams will develop a list of volunteer opportunities to be shared with parents in the beginning of the year.
